

**What is the Voucher Program?**

Local businesses have partnered with HCS to show our families some love by offering rebates for purchases. These rebates are submitted to the school as a voucher and applied to your family's tuition or to whomever you allocate your earnings. Each business has different rules to qualify and percentage so please take note of special instructions.

**Voucher Procedure**

1. Families must have a completed [registration form](#) with the TRIP office.
2. Present the Voucher slip (Vouchers are located in the main office) at the time of purchase.
3. Fill in the top portion of the form (family name-adults, address and TRIP account number).
4. The business will fill in their information (purchase amount, percentage and tuition credit).
5. Keep the pink copy for your records. Business keeps the white and yellow.
6. Credits are processed when the business sends a check with earnings and are credited at the end of the quarter it is received.

**Voucher Policies**

1. Our businesses have agreed in good faith to send the tuition credit to HCS-TRIP. HCS-TRIP is not responsible for any changes, stipulations added to the guidelines printed on here or on the Vendor Voucher List or non-payment.
2. Sale and clearance items are generally exempt from the Voucher Program unless the business states otherwise.
3. Each business has the right to refuse a Voucher if the above guidelines are not followed or for any other reason.
